Our NPU-O Chair Shawnalea Garvin-Campbell (404-524-5911) brought to the membership's attention a plan by the Georgia Regional Transportation Authority to develop the 20-acre Pullman Yard site on Rogers Street in Edgewood into a bus maintenance facility. Because of issues with the traffic, noise, and pollution that such a plan might bring into East Lake and our neighboring communities the ELNCA has agreed to express its concern about the project to GRTA.

BEER AND WINE LICENSE FOR ONE STOP FOOD MARKET

One Stop Food Market is located at 2365 Hosea Williams Drive (the South East Corner of Hosea and 2nd Avenue). The ongoing business is being transferred. Therefore, they have come before the neighborhood asking us to recommend approval of their application. The owner has spoken to Mr. Lee, of the Candler Park Food Mart, about how to turn her business into something similar to his. After much discussion where the membership expressed concern with illegal activity at the corner, the body voted to recommend denial of the petition.

The membership then voted to have Kathleen Lendvay, a neighbor living near that corner, form a committee to create a list of preconditions that the business would have to meet before the committee would recommend that the membership approve the application.

EAST LAKE DEVELOPMENT CORPORATION REPORT

Tom Harding has been given parameters within which to sell the house on Memorial Drive next to Eckerd Drugs. Several offers have been received and negotiations are beginning.
